



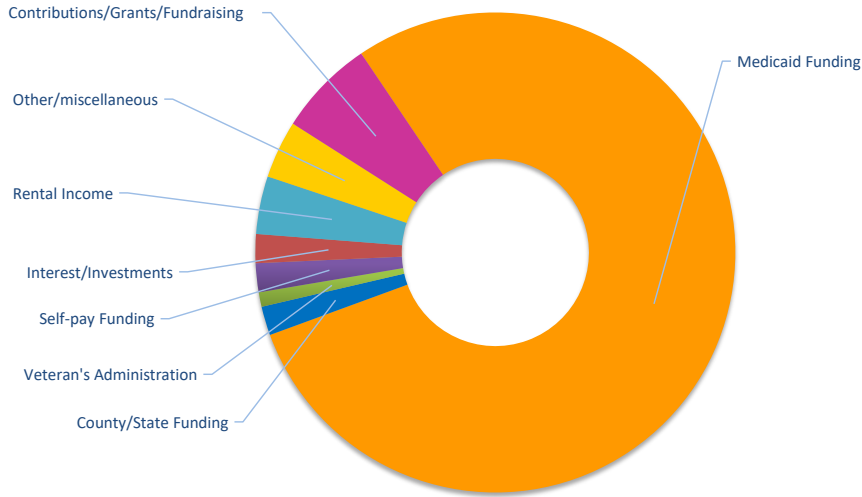

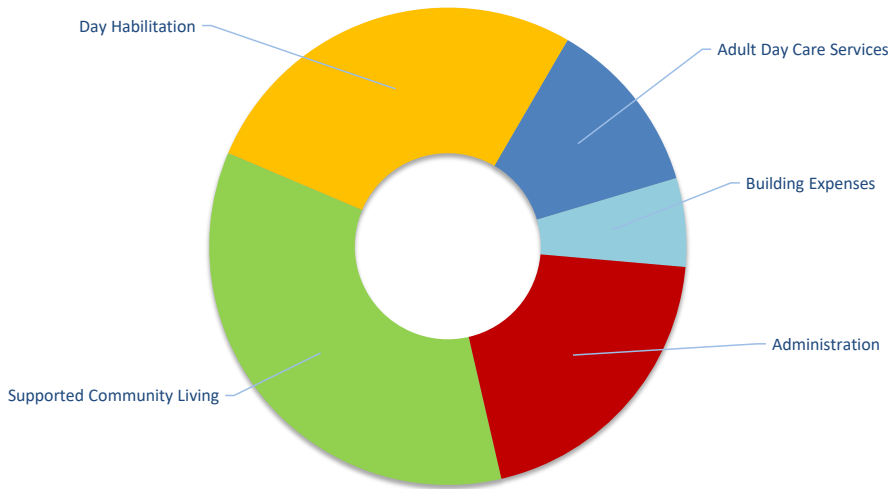

PUBLIC SUPPORT & REVENUE = \$4,336,772

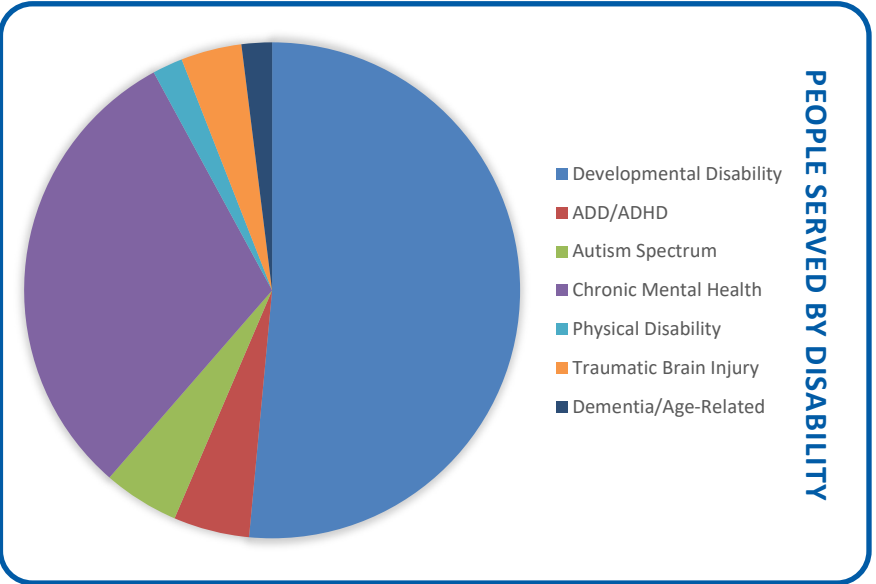
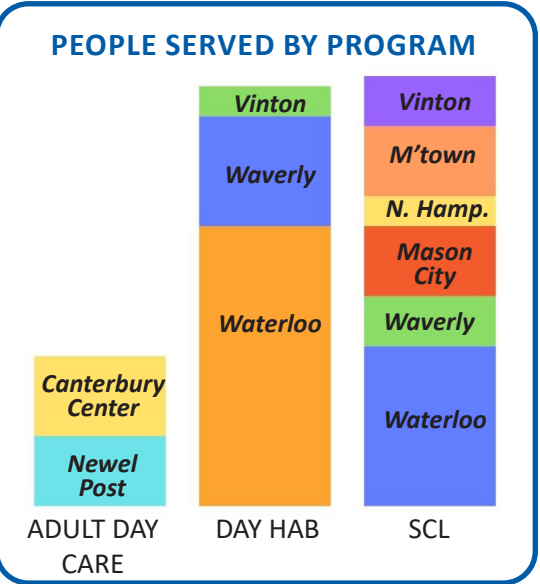
